RULES FOR HOSTEL RESIDENTS

The resident of the boys / girls' hostel is required to maintain the following rules and regulations while they are living in the hostel:

- 1. Hostlers are required to maintain the hostel timings as per following:
- a) Hostel gate will be open at 5:00 AM in the morning and will close at 9.30PM (for Boys) and 5:00 AM in the morning and will close 9.00 PM (for girls).
- b) Before going to the respective hostels each hostler is required to make the attendance in the attendance registers available at Security Gate.
- c) The Discipline Proctor will sign the attendance register.
- d) Respective wardens will sign the attendance register.
 - 2. **RAGGING** in the hostel is strictly prohibited and any matter reported, the name of the concerning student will be struck off from the roll of the Institute.
 - 3. Late night permission will be granted on specific reasons as per following: For girls up to 9.30 PM and for boys up to 10.00 PM. Late night will be granted on written request duly signed by the respective wardens only once in a month.
 - 4. Discipline Proctor will be responsible for any occurrence of RAGGING in the Hostel; he is advised to report the matter immediately to the respective wardens.
 - 5. Night out permission will be allowed once in a month on written request with due permission of wardens and due consent of the parents.
 - All the hostlers are advised to give the name and address of the local guardian to the respective wardens along with telephone nos. Hostlers are also advised not to carry costly items such as ornaments and not to keep cash in the room.
 - 7. The hostel for the next higher class will be allotted on the basis of performance in their preceding exams.
 - 8. Each hostler is required to maintain 75% attendance in theory and practical classes. In case of shortage of attendance, the hostel facility will be withdrawn.
 - 9. All the hostlers are strictly advised not to entertain any day scholar in the Rooms/Hostel Premises at any time, if matter reported, the hostel facility will be withdrawn.
 - 10. Any loss of valuable items, Institute will not be responsible.
 - 11. If case of emergency or sickness, hostlers are advised to report to the respective Wardens Immediately.
 - 12. The doctor facility is available in the Institute on every Wednesday from 3.30 to 4.30 PM.
 - 13. Smoking / Gambling is strictly prohibited in the hostel.

- 14. The consumption liquor is strictly prohibited in the hostel, if anybody found, drunk He/she will be rusticated from the Hostel.
- 15. Hostlers are also advised to avoid taking drugs etc. in the hostel, if any matter reported, he/she will be expelled from the Hostel.
- 16. Hostlers are advised to maintain the hostel property in a good form and damages occurred deliberately a fine of Rs. 1500/- each from the reported hostlers will be charged and concerning hostler will be bound to replace/repair the items damaged or cost of breakage.
- 17. Hostlers are advised to maintain their room clean, if anybody's room found dirty a fine of Rs. 200/- will be charged.
- 18. Hostlers are required to go to bed for sleep latest by 11.30 PM, if any light are found on after 11.30 PM the respective hostler will be fined Rs. 200/-. However, during examinations, the students are permitted to use the light at late night.
- 19. The Music system in the Hostel is not allowed, if anybody found using, the same will be seized and will not be given back to the students.
- 20. Use of electrical iron, heater and any electrical equipment is not permitted in the Hostel.
- 21. Cooking in any part of the hostel is strictly prohibited.
- 22. The mess is being run on co-operative basis and the mess charges are required to be deposited well in time.
- 23. Hostlers are required to take their breakfast/lunch/dinner in the hostel mess only. Breakfast 8.00 to 8.30 AM, lunch 1.00 PM to 1.30 Pm. (Saturday, Sunday & Holiday) Dinner 8.00 PM to 8.30 PM.
- 24. The consumption of the food in the hostel room is strictly prohibited.
- 25. While leaving the hostel on completion of their studies, hostlers are required to handover their room to the Maintenance Foreman and obtain No Dues Certificate. The amount of any damages will be recovered from their hostel caution money.
- 26. Hostlers are also advised to switch off the light/fan when it is not in use.
- 27. The complaint pertaining to the electric and water reported to the Maintenance Proctor, Maintenance Proctor will immediately report to the Maintenance Foreman for the immediate rectification.
- 28. In case of any scuffle the students involved will be asked to vacate the hostel.
- 29. Hostler Identity Card will be issued by the Authority and as and when asked by the Security Staff, hostlers are advised to show them their Identity Card.
- 30. The hostler is required to be vacate the hostel in case of any law and order Situation arises in the city and District Magistrate issue orders for it. At this stage hostlers are required to manage their stay on their own.
- 31. The violation of rules, no excuse shall be entertained at the level of Hostel Warden. Concern Hostler will be asked to vacate the hostel immediately.
